1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Secondary Education Society Bhalod is the oldest education society in the region. Topographically it is situated in Longitude (in degree) 75.698008 and Latitude (in degree) 21.169369. It was established in 1922 to imprint quality education to the poor rural students of the Bhalod village and surrounding villages. Now society has completed 100 years. It is an honor of the society that Dr.B.R.Ambedkar has been visited the society during a pre-independence period in 1929.

Since its inception, the society has raised its reputation by importing education from pre-primary to postgraduate level for the students belonging to various strata of society, especially for socio-economically backward classes.

The Secondary Education Society's Arts and Science College was established in 1996. To initiate the vision and mission of the founder members of the Society, the institute has been working to strengthen the needy generation of students from peasant families, landless workers, and poor downtrodden inhabitants of the neighboring area. The total area of the campus is 7.3838 acres, and the college building is constructed in an area of 312.5 sq.m. The institute has all infrastructure facilities like a building, Laboratories, library, classrooms, girl's waiting room with attached washroom, auditorium, purified and cool drinking water, 24-hour water and electric supply, and the ladies' hostel in the college campus built under UGC scheme. The college campus is clean, beautiful, and pollution free, with lots of trees and a botanical garden. The society develops and maintains its infrastructure and self-financed courses with funds generated through donations from well-wishers of the society and by the fees collected.

The college is a grant–in–aid co-educational institution affiliated with the Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon. UGC recognized the college under section 2(f) in June 2007 and 12 B in July 2009.

The college has undergone two accreditation cycles by NAAC, with a grade of C ++ in the first cycle in 2004 and with a grade of 'B' at a CGPA of 2.08 in the second cycle in Year 2015.

Each faculty is well qualified. 14 teachers have Ph.D. degrees, and 02 teachers have M.Phil. Degree and 02 teachers are NET/SET qualified. There are 11 Ph.D. guides in the college, and **10** students are pursuing Ph.D. under them.

The institute offers programs such as Bachelor of Arts, Bachelor of Science, and self-financed B.Sc. Computer Science & Post Graduation Chemistry. The College has University Recognized P.G. Research Laboratory for Chemistry.

The institute has been committed to providing quality education to students from all classes of society, especially to students from deprived and weaker sections of the neighboring area.

The college implements various programs through NSS (National Service Scheme), Yuvati Sabha (Young Girl Association), different academic committees, etc., to imbibe cultural, ethical, and extra-curricular potential among students. In this context, the College organizes activities such as poster presentation competitions, quiz

competitions, field visits, career guidance, etc. IQAC of the college monitors all these processes of improving the quality in all respects.

1. Well-lit and properly ventilated spacious classrooms and laboratories for teaching and learning.

4. The members of the management are from the fields of agriculture and have good contact with society.

5. The college has established a Research Committee to motivate college research. The faculty have published books, research papers, etc., in renowned journals, including 91 publications in UGC-listed journals.

- 8. College implements Extracurricular and Co-curricular activities for the overall development of students.
- 9. Facilities are made available to the students for sports and athletics

Institutional Weakness

1. Our institute is located in a rural region. The students belong to socially and financially weaker sections.

2. Due to rural and Farmer family backgrounds, student lack Proficiency in English speaking and computer literacy.

3. There is less number of interdisciplinary programs and courses.

- 4. Teaching and Non-teaching posts are vacant due to the government recruitment policy.
- 5. Less research activities due to lack of research grants.
- 6. Inadequate transportation facilities for some students from remote areas.

7. Low scope for placement and jobs.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

Curricular Planning and Implementation:

The curriculum is designed in the meetings of the Board of Studies (BOS) of the university to which the college is affiliated. Two of the faculties of our college are BOS members. Teachers of our college actively participate in syllabus framing workshops. At the beginning of every academic year, Hon. Principal prepares different academic and administrative committees for the smooth functioning of the teaching and other activities. A well-

planned academic calendar is prepared at the beginning of the academic year. The timetable committee prepares the college timetable. The head of each department prepares a departmental timetable and distributes the workload accordingly. The Continuous Internal Evaluation (CIE) is conducted in the college and consists of a tutorial every week for each subject, two tests in a semester for each subject, and oral and journal work for practicals.

Academic Flexibility:

One certificate course was offered during 2018-19 and 2019-20 conducted by the Botany department. A total of 44 students were admitted to the course, and all completed the course. For B.A., B.Sc., and M.Sc. programs, the college has adopted the CBCS pattern prescribed by the parent University.

Enrichment Curriculum:

Crosscutting issues relevant to gender, human values, environment, and sustainability are addressed in the curriculum of some of the courses of both B.A. and B.Sc. programs. In addition to these, students are sensitized about these important issues through various programs arranged on different occasions by some departments and committees and through NSS's regular activities.

Project work, fieldwork, and Internships:

The course 'CH-O-4 Short Research Project' is included in the syllabus of the program M.Sc. Organic Chemistry (Second Year). Thirty-one students completed the research project work during the last academic year 2021-22.

Feedback System:

The institution obtains feedback on its academic performance, curriculum, and ambiance from stakeholders, such as Students, Parents, and Alumni, and analyses them.

Teaching-learning and Evaluation

The college follows the come first, serve first policy for enrollment in undergraduate courses. The Central Admission Process (CAP) at the University for Graduate Courses monitors and controls the admission process for postgraduate courses. The number of students admitted has never exceeded the number of seats earmarked. The reservation policies of the state and central governments have been followed. The mentor-mentee scheme is effectively implemented, and the teacher-student ratio is... Pre-reading and post-reading activities encourage participatory learning (science). ICT tools are effectively used for teaching and evaluation purposes. The faculties are highly qualified. The percentage of full-time teachers with a Ph.D. as a higher qualification is 54%. The affiliating university conducts external assessments, and the college strictly follows the guidelines issued. The college conducts an internal assessment in accordance with the guidelines of the university. Every attempt is made to make the process transparent and robust.

No formal evaluation of POs, COs, or PSOs is conducted; the classroom activities and internal evaluation process are designed keeping in mind the POs and COs. The pass percentage of students under scrutiny in the first two years is below expectations. But the rigorous efforts by the faculty have proved fruitful, and the result has considerably improved in the last three years, i.e., from 2019–20 to 2021–22.

Research, Innovations and Extension

Resource Mobilization for Research:

The faculty and the college are keen to get research grants from VCRMS. During these five years, a grant of 2 78 000/- rupees is sanctioned to the teachers. The college monitors the research undertaken by the faculty and takes time to time review.

Innovation Ecosystem:

The faculties and students have produced 91 publications in the last five years in the UGC listed Journals of International/National repute (a few publications are in Scopus/Web of Science indexed Journals).

Research Publications and Awards:

Being in a rural area, the college promotes undertaking research. The result is that there are 91 publications in UGC-listed journals and 33 publications in the form of books, chapters, etc.

Extension Activities:

Adoption of a Village: NSS Unit of the college has adopted a village Amoda & Dongar Kathora in the last five years.

Pandemic Awareness: Distribution of Masks during the Covid-19 pandemic period. The volunteers designed digital banners emphasizing preventive measures and posted them in various WhatsApp groups. They also distributed sanitizers to the villagers. Some volunteers also stitched masks and distributed them among the villagers. The volunteers also explained the importance of wearing masks etc.

Cleanliness Drive: NSS Unit has organized online and offline camps or visits for awareness of Cleanliness in the community.

Health-Related Guidance: The College has Yoga Day every year to emphasize the importance of Yoga for the students, staff, and nearby Community on World Yoga Day. Also, organize Personal Health and Hygiene, Diet Awareness, and Medical Check-up programs.

Environmental Issues: NSS unit, the Students Development Department, and Various Department have organized several activities such as Friendship Day with Trees, rallies on the Significance of Tree plantation and conservation, Water Conservation through the construction of Bandhara, Social Interaction, Environmental Awareness, Disaster Management, Plastic Eradication, etc.

Collaboration: The College wishes to collaborate with various Govt. and Non-Govt. Agencies. Through these agencies, the college has carried out beneficial programs.

Infrastructure and Learning Resources

The college building was constructed on a 17946 sq. ft. area of 6.85 acres. The various departments of science

and arts faculties run in individual rooms. We have well-equipped classrooms, laboratories, and a seminar hall. The college has a spacious playground for sports activities. The college has Extra Curricular and Support Services organized by various departments. The college has a well-furnished computerized administrative office, Principal's cabin, Seminar Hall, etc., and ICT facilities and LCD projectors. The College has a Botanical Garden, a separate hall for Library; a reading room with an internet facility to access online resources like Inflibnet, Shodhaganga, EPG Pathashala, etc., and SOUL3 Software is used in the library. A Separate Chemistry P.G. Research Laboratory is available with essential equipment. Additional Physical Facilities like CCTV cameras across the campus, An electric generator, Solar panels, Three RO plants with a water cooler, Blue Star split AC, Whir pool Refrigerator, Canon Xerox, and a digital camera are used according to the requirement. The college has expenditure for infrastructure augmentation during the last five years 51.09768%

The college library is a Learning Resource Centre. Spread in an area of 1200 Sq.ft. The Library I partially automated with Soul 3.0 software. The various library activities, such as data entry, membership, etc., are done through the software. The total numbers of books in the library are about 12500, and the number of visitors per day is 10-15. Our library has a UGC-Network Resource Centre with 20 mbps internet speed. The library is the point of support for the entire teaching-learning and academic activities of the college. College Library provides users with books, journals, reference books, and N-List, e-resources. Library Advisory Committee holds meeting at regular intervals to contribute and ensure the smooth functioning of the development of the Library. The reading room is for 50 users.

IT infrastructure is available according to the requirement. There are 37 computers, 4 LCD Projectors, one allin-one color Printer, and 32 CCTV cameras installed on the campus. The College has well-designed ERP (Enterprise Resource Planning) software. As a part of the digital library system, our college library has SOUL3.0 software. Digital Podium (Lectern) with an inbuilt system, microphone system, and speakers was installed in the ICT room. The college has a Wi-Fi facility. There are lease line internet facilities from BSNL. The Office is well-equipped with different computer systems, photocopiers, printers, Xerox machines, etc. Different WhatsApp groups exist for students, teachers, non-teaching staff, HOD, etc. The student's computer ratio is 22:01. The college has spent 69.63% on maintaining physical and academic support facilities during the last five years.

Student Support and Progression

Student Support:

Our College has a tradition of student support and progression. The College provides all the necessary facilities to the students. The College offers Free-Ship and assists in getting government scholarships to students. The number of students, who benefitted from government and free-ship scholarships from 2017 to 2022, as students are significantly helped by Non-Government Scholarships of HPCL (HINDUSTAN PETROLEUM CORPORATION LIMITED), is regularly increasing.

Student Progression:

The data of the students for progression is taken through informal modes. Several committees involve student support, such as Admission Committee, Anti Ragging Committee—women's Committee, and Grievance

Redressal Committee.

Student Participation and Activities:

The students are encouraged to participate in all kinds of activities. Compared to Previous years, most students participate in Sports at the National level, achieving medals, Culture, NSS, etc.

Alumni Engagement:

The College has a formal alumni association that works for the betterment of students.

- 1. At the time of establishment of Secondary Education Society in 1922, vision and mission statements were finalized; college strictly adhered with it to impart quality education to the students in the rural area

Welfare schemes include Group Insurance Scheme, Staff Assistance Group (Paripurty), Provident Fund and Gratuity, Medical Reimbursement; Group insurance schemes, Maternity leave, and Paternity leave etc.

Our college takes various initiatives to create an inclusive environment i) by celebrating birth and death anniversaries of Eminent personalities ii) by celebrating National Festivals and important days like Voters Day, Yoga Day, etc.

2) The Research Motivation Scheme for Budding Researchers: It is an important forum to promote researchoriented study amongst U.G. Students. It aims i) to strengthen the research activity, ii) to encourage students and motivate them towards research, iii) to improve participation in interdisciplinary research activities.

7.3 Institutional Distinctiveness

The college has aimed to boost national integration amongst students and make students succeed in various competitive examinations. There is 'YUVATI SABHA' in the college, which provides a platform for female students to develop their personalities and learn self-defense lessons. The college has Career Guidance Cell to guide students in competitive examinations. The college is aware of keeping the environment eco-friendly and has planted many trees on the campus. The college installed the Solar Energy Power System as an eco-friendly initiative, which generates 10 KV of energy. Our college is the only educational institute in Yawal taluka that installed such a solar power system to generate electricity.

2. Academic bank of credits (ABC):	Academic bank of credits (ABC) is an innovative idea to earn and deposit credit through National schemes like SWAYAM, NPTEL, and AICTE. The institution is promoting the staff members and students to register on the portal of such schemes. In addition to this, a facility of Infosys Spring Board Courses is available in our institution. The institution maintains regular contact with the affiliating KBCNMU University to update the latest guidelines regarding the implementation of ABC. The college has already taken the steps forward to register the students on ABC as per KBCNMU guidelines.
3. Skill development:	Our institution will implement guidelines or structures provided by the KBCNMU, Jalgaon. Our institution offers one course of skill development at S.Y.B.Sc and S.Y.B.A. levels. Our institution is located in a rural area and provides financial support to students through the Earn and Learn Project. In addition, there are attempts to imbibe good qualities by celebrating National festivals like Independence Day and Environmental Day and observing the Death and Birth Anniversary of National leaders. There is also participation in Youth Festival, Competitions organized by other institutions. The college has established Personality Development and Career Counselling Cell through which many programs have been organized to enhance students' skills. The faculty also tries to develop research skills among students.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	The college ensures appropriate integration of the Indian knowledge system by offering MIL (Modern Indian Languages) and core courses as per CBCS set up by KBCNMU Jalgaon. 1.1 Curricular Planning and Implementation

1.1.1 The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

Response:

- The college is affiliated with 'Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon'. So, the college has to adopt the curriculum as the university prescribes. The curriculum is designed in the meetings of the university's Board of Studies (BOS) for each subject for every program, usually after three years.
- Two of the faculties of our college are BOS members. The university/BOS arranges syllabus framing/restructuring workshops for each subject at appropriate times. Teachers of our college actively participate in such workshops. In this way, teachers partially take part in the curriculum design.
- Honorable Principal calls meetings of all the staff members at the beginning of the academic year. In the meeting, Hon. Principal gives instructions about the effective delivery of the curriculum.
- Hon. Principal prepares different academic and administrative committees for the smooth functioning of the teaching and other activities.
- The chairperson/coordinator and members of each committee plan the programs for the whole academic year, and then a well-planned academic calendar is prepared at the beginning of the academic year.
- The college's academic calendar is prepared to keep in view the university's academic calendar. Each committee plans its programs keeping in view the college academic calendar.
- Every year, each teacher prepares a proposed plan for teaching and other activities according to the college's academic calendar.
- As the admission process starts, the college timetable is prepared by the timetable committee, displayed on the notice board, and shared on students' WhatsApp groups. For the departments with more than one faculty, a departmental timetable is prepared by the concerned head of the department according to the college timetable, and the workload is distributed among the teachers accordingly.
- During the pandemic, it was quite hard to stick to the college's academic calendar while implementing academic activities. Nevertheless, the academic calendar is followed as much as possible while performing departmental and other academic activities.
- In the meetings with the faculties of the departments, heads of the science departments review the requirements of the chemicals and apparatus essential for the experiments to be performed during the academic year and take necessary steps to manage all the requirements.
- The Continuous Internal Evaluation (CIE), which is conducted in the college, usually consists of a weekly tutorial for each subject, two tests in a semester, and oral and journal work for practicals. The coordinator of the examination committee monitors the whole process. Quiz Competitions, Elocution Competitions, and Poster Presentation Competitions are also organized in the college on various occasions.
- Two tests, for each subject, in each semester, are arranged by the Examination Committee. For each subject, the concerned teacher prepares the question paper. After conducting the tests and after

evaluation, the marks obtained by the students are displayed on the college notice board and are ad on the student's WhatsApp group.

1.3 Curriculum Enrichment

1.3.1 Institution integrates crosscutting issues relevant to Professional Ethics, Gender, Human Values, Environment and Sustainability in transacting the Curriculum

Response:

- The BOS of the university to which the college is affiliated designs the curriculum, and the college has to follow it. So, the college has limitations in curriculum design.
- But within these limitations, some issues mentioned here are addressed in the curriculum and some of them are addressed in the regular activities of the college.
- There is a compulsory course, 'Environmental Studies' at, entry year for both B.A. and B.Sc. programs. The course aims to create awareness regarding the issues like environmental pollution, human pollution, and the effect of the environment on human health. It also acquaints the learner with social issues like urban problems related to energy, environmental ethics, human rights, and value education. Also, it familiarizes the learners with the issues in unsustainable to sustainable development projects. After completing the course, the student learns about renewable and non-renewable resources, ecosystems, biodiversity and conservation, and solid waste management.
- There is National Service Scheme (NSS) in the college under which each volunteer gets lessons on gender equality, honesty, national integrity, social awareness, discipline and cleanliness.
- Birth anniversaries and death anniversaries of great Indian heroes like Dr. Babasaheb Ambedkar, Mahatma Phule, Savitribai Phule, Mahatma Gandhi, Chhatrapati Shivaji Maharaj are celebrated in the college. On such occasions, teachers narrate to the students the biography of these heroes to boost national integration, human values, and patriotism among students.
- The curriculum of both courses 'MAR G-111(A) Study of Specific Literary Genre: Stories' and MAR G-121 (A) Study of Specific Literary Genre: Poems' of F.Y.B.A. Marathi, help the learner inculcate the eternal values like morality, gender equality, humanity, social equality which are necessary for human beings to live life. The learner gets direct or indirect awareness about problems and their solutions at different levels of human life through the curriculum's events, incidents, environment, and dialogues in the literary genre.
- In the curriculum of the S.Y.B.A. Marathi courses 'MAR 231 (A) Study of Ideological Prose Writings' and 'MAR 241 (A) Study of Biographical and Autobiographical Writings' biographies, autobiographies, and ideological writings give the learner awareness of the social realities.
- The curriculum of the course 'Study of Medieval Marathi Literature' for T.Y.B.A. Marathi includes medieval Saint literature and the ideological literature of modern times. In these contents, social awakening and enlightenment are done in ortolcate the values like humanity, equality, and morality by attacking the undesirable customs and traditions which are harmful to human beings.
- In the curriculums of the subjects POL 232 'Reading Mahatma Gandhi' and POL 242 'Reading Dr

Ambedkar', the learner gets information about the great works of the great Indian Heroes, Mahatma Gandhi and Dr. Babasaheb Ambedkar through which human values like truth, nonviolence, social integration, patriotism are nurtured.

• By learning the course– HIS DSC A 1 History of India (1857-1950), a learner gets influenced by knowing the great contributions made by the freedom fighters in the freedom struggle and by knowing how they had devoted their whole lives to serving the Nation. Thus, human values like truth, non-violence, patriotism, morality, and sacrifice are nurtured by studying the course.

2.3.1 Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences and teachers use ICT- enabled tools including online resources for effective teaching and learning process

Response:

To improve learning experiences using ICT tools, the college utilizes student-centric techniques such as experiential learning, participative learning, and problem-solving approaches.

Learning experiences are improved using ICT tools including CDs and DVDs, instructional websites, Google classrooms, blogs, e-resources, YouTube videos, etc. Teachers use PPT presentations to facilitate more relevant teaching and learning of the curriculum. Similarly, the Arts and Science department faculty successfully supervise theoretical classroom instruction with hands-on experience through e-resources from instructional websites, YouTube videos, and NPTEL films. The college uses Facebook, Telegram, and WhatsApp groups to effectively use social media. Students are given access to all study materials; online lecture links, Google form links for internal exams, and other crucial information via various

channels.

The college has a separate Wi-Fi unit within the campus. It has an internal Network in its computer lab and an Internet connection via a broadband leased line, which is very helpful for any ICT-enabled teaching and learning tools.

All instructors delivered lectures and exams online during the Covid -19 pandemic utilizing platforms including Zoom, Google Classroom, Cisco-Webex, Google Meet, Google Form, etc. A few educators run their own YouTube channels. Various websites, e-modules on SWAYAM, NPTEL, e-books, e-journals, and inflibnet are all made for students. Blogs and Google Classroom.

The use of ICT resources offered by the college is also encouraged for PPT presentations, project reports, fieldwork, educational tours, business visits, internships, lab work, etc. In their laboratories, students work on practical projects that put to the test the application skills they have learned in the disciplines. Quantitative evaluation includes extra assignments and problem-solving. Undergraduate and graduate students receive individual and group tasks; PG students are encouraged to use PowerPoint presentations for seminars and workshops. Informal forms have also been investigated to ensure a deeper and more thorough learning experience. They include poster presentations, quizzes, competitions on various topics, and participation in Youth Festival, Avishkar, etc.

The majority of science experiments include participation and hands-on learning. The class is divided into batches, and two or three students will occasionally work together on a practical. Students frequently visit the campus' Botanical Garden to observe natural phenomena.

Via pre-reading humanities exercises, the students are inspired to share their opinions. Their participation in the conversation and brainstorming session enhances their communication and self-confidence.

Environmental Studies, a required course in the first year of both the Arts and Science degrees, asks students to identify environmental problems and attempt to discover solutions. Students who specialize in Hindi and Marathi perform the dramas required for study.

Students are encouraged to participate in fieldwork, educational excursions, and industrial visits to develop their soft skills and produce a report about it. The evaluation includes PowerPoint presentations, Google Forms for online tests and quizzes, and Google Classroom assignments. This supports students' problem-solving, experiential learning, and participatory learning.

2.5 Evaluation Process and Reforms

2.5.1 Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

The college is affiliated with the Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon. It adheres to the norms prescribed by the affiliating university and follows the evaluation structure as framed by the university. The IQAC is in charge of ensuring that faculty and students are motivated and aware of the evaluation process through interaction and counseling in the classroom. The affiliating university finalizes the system of internal evaluation, which carries 40% of the overall assessment for the theory subjects in Arts and Science, and is conducted before the university assessment, which carries 60% of the total assessment. Internal assessment is based on students' overall academic performance including attendance and general behavior.

Timetable and announcements of the internal assessment are given in the class and placed on the notice board in advance, and professors initiate talks regarding examinations to make pupils overcome examrelated stress. Students are instructed about the evaluation method and its format, and the academic calendar is publicised on the college website and notice board. Internal flying squad members and supervisors are assigned for the efficient administration of exams, and there is a zero-tolerance policy for cheating by students. During the lock down due to covid-19 pandemic, tests were conducted in the online mode.

The learner's list of grades is published on the notice board, and complaints about the examination of grades, summing of grades, and other issues are quickly addressed, repaired, and dealt with prior to record is sent to the university. To quickly address student complaints, all staff members are given instructions on proper care and teamwork. The chairperson of the Examining Committee maintains close and continuous communication to ensure that complaints and difficulties are resolved quickly. The centralized assessment program (CAP) for first year classes of UG program is being carried out in the college. Grievances related to oral, project and practical examination are resolved at the department level.

Applications are gathered and sent to the university through the principal in the event of any universityrelated complaints. Within 10 days of the result announcement, students may request an online photocopy if they have any questions about the evaluation of their answer sheets. The college sends a hardcopy of the mark list created by the teacher along with an application to repair the error at the University level for students whose marks are not entered or entered improperly due to an oversight in the University mark list. If the candidate's original and revalued marks exceed the maximum marks allowed by the university by 10% or more, they are given the advantage of revaluation.

Response:

The college is affiliated to the Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon. There are two programmes in the college: Arts and Science. The Arts and Science Programmes at the college provide students with a comprehensive and stimulating education that will enable them to think critically, communicate effectively, and solve problems. The syllabus of each programme is finalized by the Board of Studies of the university, which usually consults the practicing teachers in workshops/ conference. The final decision on the contents, method of delivery etc., is taken by the BOS and communicated to the teachers before the commencement of the academic year. The syllabus clearly states courses, elective courses, and learning outcomes of the program. It also provides information about the scheme of evaluation. The university takes a periodic review of the syllabus. Students enroll for a specific Program by learning about its details through the POs and COs. Each course's instructors periodically review the curriculum to determine its strengths and flaws and the applicability of its learning objectives. The university maintains and uses its website as a way to communicate. The instructors spend a few hours outlining and describing the POs and COs as well as the desired outcome at the beginning of the programme, and the same are displayed on the college website and notice boards. The professors also discuss the job opportunities available to the students after their course is finished.

The attainment of POs and COs is periodically evaluated through observation, evaluation, and the results of an outside investigation by each teacher as well as the head of the department. The ongoing internal evaluation and the external outcome at the end of each semester are two of the most frequently used assessment techniques to evaluate students' academic progress and determine achievement. The 40 marks internal evaluation comprises two written exams, an oral exam, lab work, attendance, and overall student behavior within the campus. The purpose of the test questions is to evaluate the degree of performance of COs and POs. The Programme outcomes and course outcomes are also evaluated through

other methods such as performance in co-curriculum, extension activity, and extra-curriculum activities. The purpose of the academic journey is elaborated through classroom interaction, counseling at the time of admission, expert lectures, etc. The university examination results are analyzed and reviewed at the university and department levels, and each program's pass rate report is prepared. The institute takes the feedback of students on the curriculum and the teacher every year.

3.2 Innovation Ecosystem

Response:

The institution has created an ecosystem for innovations and other initiatives to create and transfer knowledge.

Response: There is no separate incubation center in the institution. But various activities are conducted to develop a research culture and scientific temper among the students as follows: Institute has a research committee that motivates faculty members and students to undertake research projects. Newly appointed faculties also benefit from the activities that govern their career path. It is not only helpful to the faculties but also for the students to get innovative ideas. At the same time, this knowledge applies to society's development. Research Policy of Institution:

Seed Money: There is no provision of seed money in the budget for the teachers involved in research activities.

Research Grants: The Principal and Research Committee encourage the faculty members to file proposals to various funding agencies for financial assistance in the form of Minor and Major research projects.

Leave: If needed, the Institution has sanctioned duty leave to teachers to complete their research project.

Other Facility: The research is going on in the respective departments of the Principal Investigators. Different departments have the required research facilities in the form of instruments and apparatuses. The laboratories of the Chemistry, Physics, Zoology, Botany, and Computer Science departments are used by undergraduate students for experiments stated in the syllabus. There is a separate Chemistry PG Research Laboratory.

Research Facilities: Many Research facilities are made available to the research scholars on campus. They are as follows:

i) Broadband Internet facility, ii) Reference books in the Library, iii) LCD Projector for PPT presentation, iv) Computers with Printer and stationery.

Students are encouraged to participate in research activities.

The students are sent to participate in a research seminar, workshop etc. Our students participate in the 'Avishkar Competition' organized by the University. Under the Environmental awareness program, students actively participate in research projects. Though the college is committed to creating a conducive environment for research, it may not support all research proposals due to limited resources. But it makes available the infrastructure facilities and other resources for research programs. It also allows researchers to write research proposals, reports, publications, etc.

Students are encouraged by the faculty to participate in academic and co-curricular events. So most of the students of various departments participate in intercollegiate, state-level seminars, PowerPoint presentations, and poster competitions conducted by other institutions. Workshops, Seminars, Industrial Visits, and Study Tours are organized to impart practical knowledge of subjects to the students. Eminent personalities who have significantly contributed to subject and research activities are invited for guest lectures. To enhance innovative ideas, students are encouraged to participate in 'Avishkar,' a research festival organized by K.B.C.N.M. University, Jalgaon. Our students have made remarkable contributions to it. Essay Writing, Paper presentation, PowerPoint presentation, Poster, and Model competitions are organized by a few departments, providing a platform for the students to show their ideas and innovations.

3.4 Extension Activities

The institute organizes a number of extension activities in the neighborhood community to impact and sensitize students to social issues and holistic development. The students of our institute actively participated in social service activities leading to their overall developments. The institute effectively runs National Service Scheme (NSS). Through this unit, the institute undertakes various extension activities in the neighborhood community. NSS unit of college is a group of Two hundred Volunteers. But During the academic years, 2020-21 and 2021-22 the special camp was not held due to restrictions of COVID-19 Pandemic. The social awareness rally is arranged at morning every day during camp by the NSS students. Several extension activities are carried out by NSS students addressing social issues which included Cultural programs, Swachha Bharat Abhiyan, Tree plantation, Water Conservation through construction of Bandhara, Shramdan, Social Interaction, Group Discussion, Eradication of Superstition, Environmental Awareness, Women Empowerment, Equality and National Integrity, Cashless Economy, Cleanliness Drive, Disaster Management, Aids Awareness, Health Check-Up Camp, Ekta Daud for Health, Cleanliness of cremation ground, National Equality Awareness, Plastic Eradication, Female Foeticides, Water Conservation etc. The NSS students interacted with the villagers regarding social issues. They conducted surveys to collect information of their basic amenities. NSS unit of the institute is conscious about its responsibilities for shaping students into responsible citizens of the country.

The NSS department organized various programs i.e. Environmental Awareness, Personal Health and Hygiene, Diet Awareness, Road Safety, Tree Plantation, Road- show Programmes for community, Cleanliness Drive, Plastic Free Campus, No Vehicle day, Yoga Day, Women's Day, Jananisuraksha, Programme on Female Foeticide, organizing visit to Orphanages and Anganwadi, Voters awareness, Blood Group Detection, Health Check-up camps, Distribution of Masks during Covid-19 pandemic period. The volunteers designed digital banners emphasing preventive measures and posted them in various whatsApp groups. They also put placard in front of their houses urging people to keep safe distance, wash hands

frequently, and come out of house if it is absolutely necessary. They also distributed sanitizers to the villagers. Some volunteers also stitched masks and distributed them among the villagers. The volunteers also explained the importance of wearing mask etc. All the above mentioned activities have positive impact on the students and it developed student community relationship, leadership skill and self-confidence of students. It also helped in cultivating hidden personality of students and created awareness among students.

The college campus area is 7.45 acres, on which building construction is 17946 sq. ft. The various departments in Science and Arts streams are located in separate rooms. The Classrooms, Laboratories, and Seminar Halls are well equipped with a computing system and Internet facilities. In front of the building, the college has a spacious playground for sports activities. The college has cultivated an atmosphere providing importance to Extra Curricular and Support Services organized by the Physical Education, Library, and National Service Scheme departments.

The academic and infrastructural facilities are as follows:-

- A well-furnished computerized administrative office and Principal's cabin
- Well-furnished 11 class rooms. The dimensions of the classrooms are sufficient for the students and to carry out the lectures.
- Well ventilated Departments of Botany, Zoology, Physics, Chemistry, Computer Science, NSS. Cleanliness, light and ventilation facilities are maintained in the classroom and laboratories.
- Well ventilated Seminar Hall with ICT facilities and LCD projectors.
- Well-equipped Multipurpose hall with a capacity of two hundred students. The Multipurpose Hall has been very useful for various curricular, co-curricular, and extra-curricular activities such as seminars, conferences, workshops, guest lectures, student welcome functions, etc.
- College has a Botanical Garden where the students study flora, fauna, and different aspects of medicinal plants.
- A spacious playground is available for outdoor games, viz. Volleyball, Archery, Kho-Kho, Kabaddi, etc. Indoor Games Facilities for the events like Chess, Table Tennis, Carom, etc., are provided to students on the college campus.
- There is a separate hall for Library. It has a reading room with seven computers and provides the internet facility to the faculty and students to access online resources like Inflibnet, Shodhaganga, EPG Pathashala, etc. There are 12481 books, 2 journals, 164300 e-books, and 6000+ journals (under N-LIST) available in the library. SOUL3 Software is used in the library.
- Science laboratories are well-equipped for conducting practicals of different courses. A Separate Chemistry P.G. Research Laboratory is available with essential equipment.
- Separate ladies room with essential facilities is available on campus.
- The college has a separate hostel for women within the campus.
- Additional Physical Facilities: 32 CCTV cameras across the campus to ensure the safety and

security of students, faculty, and assets. An electric generator of **50 KVA** power to ensure an uninterrupted power supply of **32** Solar panels generating **10 KW** power. Three **RO plants with water cooler (300 liters)** for drinking water facility.

- The college has three Blue Star split AC, Whir pool Refrigerator, Canon Xerox, Digital Camera, and they are used according to the requirement.
- 24x7 security guards on the campus. The College bus provides transport to required students.
- Staff rooms are well-equipped with LAN and Wi-Fi connectivity.

The College aspires to focus on the overall personality development of the students along with academic excellence. Science Association is an extension program. The purpose of this best practice is to inculcate

scientific temper among the students and to reveal scientific principles. It is one of the best practices used to realize the goals of the College., the empowerment of rural students and bringing about social changes.

Objective

1. To motivate students to collect and communicate scientific information and update their knowledge about science and technology.

2. To sensitize students towards current global environmental issues like plastic waste, environmental pollution, electronic waste, and sustainable biodiversity protection.

3. To provide students an opportunity to interact with experts from different spheres of science.

4. To inculcate interest and build confidence among the students whose academic performance is average or below average.

5. To create an interlink between UG and PG students.

6. To bring forth the team spirit and leadership qualities of the students.

Context:

In the direction of achieving this goal, at the beginning of the academic year, Science Association is established. The Principal appoints one Assistant professor as a coordinator of the Science Association. etc. Initially, a tentative schedule of programs is prepared. The coordinator assigns responsibility for each activity or program to one teacher of the science association committee as an observer and guide.

The Practice –

The goal of the practice is to ensure all-round participation. Over the last few years, the college has been organizing different programs and activities under the science association. Initially, the association makes a tentative schedule of programs or activities to be taken. For the last two years, the Association has conducted the following activity.

i) **Power point presentation** competition for the students: -It is an easy program to use for presenting and sharing their ideas and information, to creates curiosity and creativity, create self-confidence when presenting their ideas on PowerPoint presentations, create awareness about preparing power point presentations, animations, to creates self-confidence while preparing. These models also create social awareness and cooperation among the group members.

ii) **Seminar competition** for students: In today's education system communication skill and presentation are the most important part of personality development. For that, the association organizes a seminar competition for students. The topic of the seminar competition is related to the syllabus.

iii) **Essay competition**: On different latest issues, we invite essays from B.Sc. and B.A. students, which are evaluated by exept from college.

iv) Science Day celebration: This is the last activity of the science association. On the occasion of science

day, we invite a guest to talk on science, recent trends in science, and the contribution of Indian research in today's science.

Obstacle Encountered and Resources Required

1. Most college students live outside the town, so they cannot give extra time for programs and associations because of their bus timetables. 2. Activities students don't have laptops, Computers, etc. 3. Association has no sponsorer

Impact of the practice

1. The college motivates the students to have increased involvement in the programs organized by the chemistry association. 2. Student response is excellent. That's why we teachers feel delighted.

2. Title: Research Motivation Scheme for Budding Researcher.

It is an appropriate forum to promote research-oriented study amongst U.G. and P.G. Students. This venture will go a long way in the creation of a conductive research atmosphere among student's community.

Objective:

1) To strengthen the research activity 2) To encourage students and motivate them towards research 3) Improving Participation of Students at U.G. level in interdisciplinary research activities. 4) Creating an interest in research among students through individual or group research projects.

Context:

In the direction of achieving the goal, at the beginning of the academic year, each department selects some students who have an interest in research. The topic of the small research project, survey, and field project is given to students. The teacher observes each activity of students and guides them to prepare a project or a review article on the research topic.

The Practice:

In order to inculcate scientific temper among the students and to create interest in research college has decided to start a Research Motivation Scheme for the students at the undergraduate level. The teachers of the college motivate students of S.Y. and T.Y.B.Sc,to use ICT tools for the collection of research articles, and theses different types of resources. Under the research motivation Scheme for Budding Researchers, some students from undergraduate courses perform small research projects along with PG students. Some departments arrange guest lectures of eminent personalities on the subject related to research activity. The activity like preparation of a review article, a small research project, a PPT presentation on various current issues are performed under this scheme.

7.3 Institutional Distinctiveness

7.3.1 Portray the performance of the Institution in one area distinctive to its priority and thrust within 1000 words

Response:

Arts and Science College, Bhalod, is run by the Secondary Education Society. The society was established in a rural area in 1922 during British rule. Before starting the distinctiveness of the college, it is necessary to mention the distinctiveness of the secondary education society under which the college runs. The society runs various educational institutions like Nurseries, Primary Schools, New English Schools, Junior colleges, and Senior college. New English School was established in 1925. During the British period, it shaped the minds of many freedom fighters. Many alumni of the school have occupied top posts like the Chief Election Commissioner of Maharashtra and the Chief Superintendent of Maharashtra Police. Speaker of Maharashtra Legislative Assembly, Member of Parliament, Member of Legislative Assembly, and leading Industrialists. Many freedom fighters and social reformers have visited the institution, which includes Dr.Babasaheb Ambedkar, Sane Guruji, and the historian Babasaheb Purandare.

The college was established in 1996. The main aim of establishing the college is to provide opportunities for higher education to learners, especially female learners. Now the college has provided an opportunity for higher education to these learners. More than ten villages near Bhalod have benefited from the college.

To boost national integration amongst the students, we have a National Service Scheme under which each volunteer gets lessons on National integrity, social awareness, discipline, and cleanliness. The college has also aimed to make students succeed in various competitive examinations. With the help of the Carrier Guidance Cell, we guide MPSC, UPSC, and other competitive examinations. There is a 'YUVATI SABHA' in the college, which provides a platform for female students to develop their personalities. They also get lessons on self-defense on this platform.

For the use of ICT in college, the teaching college has upgraded the teaching-learning process by installing two LCD projectors, and all the departments have computers. Two laptops are available for fulfillment of need. The college has an internet facility by providing routers, modems, and a Wi-Fi access point with 20

Mbps speed. Around 60 computers are available for the teaching-learning process. Most of the work of the college is performed with ERP Software. Teachers use different online platforms for online teaching.

To strengthen the research aptitude, the college has upgraded the laboratory facilities by recognizing the chemistry department laboratory as a recognized PG research laboratory equipped with the necessary instruments and types of equipment. It resulted in sanctioning of minor research projects of faculty members and the publication of research articles in reputed national and international journals.

The college is aware of keeping the environment eco-friendly and planted many trees on the campus. As an eco-friendly initiative college installed the Solar Energy Power System which generates 10 KV of energy. Our college is the only educational institute in Yawal Taluka that installed such a solar power system to generate electricity.
