The MoU aims at skills development by providing various trainings to the students and faculty members of Secondary Education Society's Arts and Science College Bhalod. Taluka-Yawal, Dist-Jalgaon.

Through this Memorandum of Understanding, the two parties agree to the following:

A steering committee will be set up to monitor the activities of the MoU. The committee will consist of Mr. Arun Baliram Chaudhatri (Director, Sunshine Kraft. Jalgaon) and Dr. K.G.Kolhe (Principal Arts and Science College Bhalod)

- (d) ASC Bhalod will provide all necessary infrastructures such as Seminar hall, Projector, computer lab, etc as will be required for such program from time to time.



(e) Validity: This MoU is valid for a term of two years from the date of signing unless terminated earlier or extended by mutual agreement of both the parties at latest thirty days prior to the expiry.

(f) Miscellaneous:

All conditions, changes, erasures, amendments, waivers, etc. shall only be in writing, duly executed by both the parties.

This MoU and any amendment thereof are limited to the purpose of MoU only.

This MoU sets forth the entire agreement and understanding between the parties with respect to the subject matter hereof and merges all discussions and negotiations between them, prior to such execution.

This MoU shall be governed by the laws of the Republic of India.
